## Convention **Proclamation**

GREETINGS:

By virtue of the authority vested in me by the Constitution and By-Laws of the League of United Latin-American Citizens, I hereby issue a call for a National Convention of the League to be held in the City of Austin, Texas, on Friday, Saturday and Sunday, June 11, 12, 13, 1954 for the purpose of transacting the official business of the League and other such matters as may be properly presented to the National Convention.

As to delegates, Article IV, Section 1, page 7 of the Constitution provides as follows:

A minimum of two delegates and two alternates duly elected and accredited from each active council which shall have not less than ten nor more than twenty active members in good standing, and an additional delegate and alternate when said council shall reach a membership of twenty-five, and one additional delegate and alternate providing, however, that no one council shall have more than seven delegates and seven alternates.

It is my sincere wish that the forthcoming convention will be filed with purposes and fulfilled accomplishments of our League carried forth in the spirit of brotherhood and understanding. May God crown our efforts with success.

## EDITORIAL:

#### LULAC AND ITS GOOD PUBLIC RELATIONS

The standard requirement for a successful organization in our present-day society is that 90% of its work be devoted to perspiration or doing good and the other 'ten per cent to advertise it. LULAC in its twenty-five years of existence has fulfilled the greater part of this community work as any intelligent observer of our work can readily see. It has more to tell in the way of social usefulness than any other organization and a lot more than any large organization existing in our economic and cultural structure even if the situation is only seen from the standpoint of our youthfulness.

Even tho' we are more qualified than most organizations in our claim to broad social benefits introduced into our society, LULAC in the past has ignored the ten per cent necessary for successful existence. A program launched by our publicity department was designed to bridge the gap between the League and its public. We are now broadening the program to include monthly schedules each carrying a message to the councils pointing out the many ways in which LULAC can better serve in its role of Community Service.

These monthly programs have been carefully thought out, and designated to make the public conscious of many long forgotten developments which the League has contributed. If the people are made to realize the many socially-useful things we have done in our twenty-five years of responsible existence, and the fact that the League itself stands for these things, LULAC will come to mean something tangible in the daily lives of millions. It is not enough to merely "belong". We are saying belong and work for the organization so that we may continue to enjoy the way

of life to which you have been accustomed by guaranteeing the existence of those things we hold so necessary to daily life.

The monthly programs not only fulfill the need for creating a feeling of good-will in the many communities involved in our day-to-day existence but provide for the councils the much needed stimulus for healthy community work promotion campaigns. If the programs are used as directed and with the same enthusiasm which has gone into their preparation the League will enlarge the number of people who will speak of it with the respect it has earned through its twenty-five years of community work.

This, our anniversary year, has provided the effective springboard for the public relations program of the League. Our anniversary motto is being used in each of our letterheads and envelopes to lend even greater weight to the strength of the messages in our monthly programs. Continue to use these monthly programs as periodically provided so that there shall be no lag in this community work program. We are determined to tell of the social usefulness of the League and its influence to bring about closer relations between peoples.

## from your National President

Dear Edward:

I am anwering your letter in this fashion, because I am sure that you will agree with me that the discussion of your thoughts as expressed to me in your letter and as answered by me herein concern all of the members of our organization.

It was with great regret that I learned of your resignation from the League, for I believe that you sincerely believe in your reasons for resigning. It is impossible for me to agree with your reasons altogether.

That our organization is dedicated to the proposition that we must integrate with our fellow Americans cannot be denied, but are we, in this integration, committed to the idea that we must also lose all vestige of a culture and heritage which we possess, and which is undoubtedly a part of our very being? Does integration to you mean the breaking of all ties with your ancestors, and assuming a character which God has not given you? Can you truthfully state that it is impossible to be a true American with all your soul, a lover of this great country and its ideals, and at the same time love frijoles, and chili and tacos; and yes, Hay Jalisco no te Rajes? I do not believe so, for America derives its greatness from integrated Americans such as the Irish who wear their Green and dance their beautiful dances on St. Patrick's Day: the Germans with their resplendent bonfires at Eastertime, the Italian with his Pizza and his beautiful songs. Remember our official prayer? It states that we are gathered here out of many kindreds and tongues. All Americans nevertheless.

No, Edward, I am afraid that we cannot become more acceptable members of our society by stifling the heritage which we possess, for doesn't our Lulac Code, in its very second paragraph teach us to be proud of our origin and to maintain it immaculate?

It is my humble opinion that the ideal of integration as the sole purpose of Lulac is not only unwise, but is doomed to failure; for we have a unique situation amongst us, in that there is a constant influx of immigrants (braceros and wetbacks too) that make the process of integration a perpetual one. I would venture to say that a sudden stoppage of this immigration would find us fully and completely integrated within a single generation, but such is the situation, and we must be satisfied with plugging along in our efforts to decrease poverty amongst us, to terminate inertia and complacency so prevalent in our midst, to interest the indifferent, and by education and edification decrease our identification as beings foreign to this country to be used only in those jobs which others will not have.

We must act with the absolute knowledge that our culture and background are equally virtuous than the culture and background of our European or any other neighbors, that we can't and musn't feel ashamed of it, but should endeaver to make the better aspects of it, a part of the American way of life; realizing that in this, we have made a great contribution to the joys of life in these United States.

In any event, whether you are right or I am; whether both of us are right or both of us are wrong, the fact remains untouched that only through organization are we to achieve the maximum of happiness and respect for our people. We cannot, if we realize our personal responsibility to them, be like the little boy who would take his marbles home if the kids don't play the game his way. Re-join Lulac, Edward, it is a great organization with even greater opportunity for a person such as you to accomplish his purpose upon this earth.

#### Reactivation of Denver Lulac Council:

Bro's G. P. Gutierrez and J. W. Trujillo gave the assembly a verbal report on the recent 'reactivation' of the Denver Lulac Council, on March 27-28th. Bro. Dan T. Valdez, District Governor for Colorado, was instrumental in organizing this Council. Bro. Valdes invited the Los Alamos, Santa Fe, and Española Councils. All were represented. Bro's E. E. Garcia, S. O. Sandoval, C. P. Gutierrez, and J. W. Trujillo represented this Council.

Among the dignitaries of the League present were: Armendariz, National Pres., L. Santoscoy, Ntl. Director of Publicity, I. Sandoval, Regional Governor for Colo., and our District Governor, A. Gonzales.

Dr. Ernest Bustamante was elected President of the new council. The initiation and banquet were held at the Albany Hotel. During the banquet, held at the Mural Room, Miss Mercedes Jaramillo ("Miss Denver of 1951") was crowned LULAC Queen by our National President. Eloy Mares, one of Colorado's outstanding allaround athlete, was presented with a plaque by Dr. Bustamante.

The keynote speech was delivered by our National President. Armendariz stressed the great need among Spanish-Americans for education to develop leadership. Stating that "... education is not only a right but an obligation," he went on to say that "... we must develop that sense of leadership so our people can rise above their origin." "... No one is going to do this job for us—no one is going to give us our

leaders—we must do the job our-selves."

During the ceremonies the Council was recognized as one of the best organizations in the League, and Bro. J. W. Trujillo was acknowledged as the outstanding Secretary of the League.

#### Supreme Council's Meeting— Deming, New Mexico

Bro. Ramon C. Quintana gave a verbal report on the Supreme Council's meeting held in Deming, New Mexico, on February 20-21st. The National President and other National officers were present.

President Armendariz expressed deep concern at the lack of expansion in the way of organizing new councils. He added that various organizers, District Governors as well as Regional Governors had "...perhaps not been as zealous as they could be in continuing the progress of the League ..."

Bro. Armendariz proposed that Section 7 of the constitution be amended at the National Convention in Austin ". . . whereas the District Governor's Office, while continuing to be an elective office, nevertheless should serve under the jurisdiction of the Regional Governor, and further empowering the Regional Governor to initiate "impeachment proceedings" if it was deemed necessary by the respective district councils, if respective District Governor was not fulfilling the duties of said office.

Also discussed was the term of office for which a District Governor is elected. It seems that said officer is elected to an indefinite term, thereby his tenure of office can literally be held indefinitely regardless of whether this officer is carrying out the intended duties as set forth by the National Office or not.

Another point brought out by the National President concerned Section 8 of the constitution. "... whereas only one (1) Jr. Council is allowed to be sponsored by a parent Council in any one given city, the National President feels that it should be amended to allow for two Jr. Councils in a given City, if the need for such a step was deemed wise by the respective parent Council."

Talk of replacing the word LAT-IN on the official name of the League brought forth the usual volley of 'pros and cons.' This issue will definitely be settled at the forthcoming National Convention.

Bro. Armendariz advocates the hiring of a professional advertising man to solicit ads for Lulac News. Armendariz believes that this act would insure an increased revenue. He proposed that revenue derived from this sources be divided thus: 30%, Professional Services; 60%, National Office; 10%, to respective Council in whose territory the revenue is raised.

The President of the Deming Lions Club, one of the speakers at the meeting, elaborated on the local Lulac Council's contributions to the community and unequivocally stated that Deming was proud of the Council for its great work in that part of the country.

This Council came up for special praise, and especially recognized was Bro. Bennie Maes for his fine work in "juvenile delinquency."

In closing, Bro. Quintana stated that he and Mrs. Quintana found the meeting very enlightening and constructive, and generally speaking had an enjoyable trip and a wonderful time.

#### **New Business**

Motion to establish a Recreation Committee was made by Bro. B. Meas, and seconded by Bro. C. P. Gutierrez. Motion passed. The main functions of this committee will be to take an active part in "Youth Activity." Members volunteering their services: B. Maes, C. P. Gutierrez, M. F. Martinez, S. D. Sandoval, L. Silva and L. G. Rojas.

Motion to sponsor a Police "Little League" Team (ages 13 to 15), and to further commit the Council to a \$300 assessment to outfit this team was made by Bro. C. P. Gutierrez and seconded by Bro. M. F. Martinez. Motion passed. Bro. Martinez stated that his team will carry the LULAC banner, and will in 1955, be affiliated with the "Babe Ruth National League."

Bro. S. O. Sandoval moved that the Council submit the name of its Secretary, Bro. U. W. Trujillo, to the convention as a candidate for the office of Regional Governor. Motion was seconded by Bro. B. Maes. Motion passed unanimously. Bro. C. P. Gutierrez moved to instruct the delegation to Bro. J. W. Trujillo. Bro. E. E. Garcia seconded the motion. Motion passed unanimously.

Bro. J. W. Trujillo expressed sincere appreciation to the Council for the honor bestowed on him. He went on to say that he had been urged to seek the office by members of this as well as the Santa Fe and Española Councils. Bro. Trujillo went on to say that he would let his work for the Council as well as the League speak for itself . . .

that if elected, his main endeavor will be to perpetuate the Aims and Purposes of the League, adding emphasis to the organizing of more councils, and maintaining the current Councils strong and active. Bro. Trujillo solicited the support of the Lulac Ladies present.

### Port Arthur, Tex.

President Dominguez reported that a committee to collect funds for the deceased, Mr. Tony Rodriguea, was composed of Bro. Reyes Collazo and Bro. Julian Sanchez. The quick thinking and thoughtfulness of Bro. Salvador Ybarra was responsible for this action. This committee collected \$97.45. President Dominguez also reported that the Junior Lulacs with Miss Flisa Dominguez, the president in charge, had collected \$37.97, making a total collection of \$135.42.

Bro. Manuel Vera Jr., publicity chairman, will acknowledge to the many who contributed through the newspaper.

LULAC Council No. 217 met at the Boy Scout Hut, 326 Thomas Boulevard, on March 14, 1954, President Jose A. Dominguez presiding. A quorum of 14 was present. The applications for membership of Manuel Vera Jr. and Alfonso Ramirez Jr. were approved, and the applicants were accented as prospective members. Alfred Valdez and Manuel Vera Jr. were initiated and given the oath by President Dominguez. Alfonso Ramirez Jr. will be notified of his acceptance.

Brother Albert Cadena advised that Council 235 of Beaumont was scheduling a special meeting for March 28, at which Past President John J. Herrera and other prominent LULACS would speak. Our Council was urged to attend.

Brother Frank Rodriguez introduced a motion designed to facilitate the reinstatement of members in arrears. He suggested that such members pay an initiation fee in addition to the current month's dues that are due, and be readmitted. The matter is pending.

A letter from Brother Paul P. Silva, Junior LULAC Supervisor, was read. Brother Silva advised that the Juniors' meetings were very successful, and that they had celebrated their first anniversary with a weiner roast at Jaycee Park. A request by the Junior LULACS that they be allowed to sell hotdogs after our Council meetings was approved.



This meeting was held at the Tepeyac Hall in order to allow the members to partake of a Mexican supper served by the C.Y.O. and at the same time to enjoy the entertainment if they wished to do so. Several of the members availed themselves of the opportunity and subsequently withdrew to the room reserved for LULAC for the evening and the meeting got underway.

A first reading was given the application of Enrique Rodriguez.

Gonzalo Diaz and Alex Martinez are to represent the council at the meeting of the Central Council of Social Agencies to be held Thursday, May 6, at the Hospitality Room of the El Paso Natural Gas Company.

#### Reports of Committees

First to report was Conrado Ramirez of the Ways and Means Committee who acquainted the council with the progress being made on the tentative plans for the Feria de las Flores. Mr. Ramirez mentioned that two or three clubs are to be approached with the idea of furnishing a queen for this festival. Mr. Ramirez presented several suggestions and the council agreed to the scheme—the committee is to go ahead as scheduled. Mr. Ramirez at

#### A. F. of L. Banner Praises LULAC

(Editor's Note: The following article is reprinted from the "A. F. of L. Banner," published by Aluminum Workers Local No. 220, Point Comfort, Texas, December, 1953. The publication is edited by Mr. W. C. Jackson, an untiring humanitarian, and a friend of LULAC. Brother Gene Gutierrez of LULAC Council 184, Palacios, Texas, has been active in spreading the LULAC message, as evidenced by this excellent writeup on LULAC. Gene also advises that almost 50% of the officers of Aluminum Workers Local No. 220 are of Latin-American extraction, a thing unheard of before in that area of Texas. A fine implementation of the principles LULAC stands for!)

The League of United Latin-American Citizens is a service organization dedicated to the highest civic and patriotic ideals. The League, or LULAC, as it is often called, has been particularly effective here in Texas and the Southwest in promoting justice and equality of treatment for American citizens.

The LULACS often quietly work behind scenes to resist un-American tendencies that deprive citizens of their rights in educational, economic and civic activities. In a quarter of a century the League has made great strides towards these goals. What many Latin-American citizens now consider as commonplace opportunities were unheard of a few years ago.

Two years ago when tsis Union negotiated our agreement containing the famous Article IX, the news spread from New Gulf to Raymond-ville, that this Union wrote a non-discrimination clause in its contract that guaranteed equal opportunity for all. The LULACS, of course, didn't negotiate our contract, but the high aims and principles they had practiced for years, influenced the thinking and attitudes of the Union membership.

The aims and principles may be summed up in the LULAC Code, which says in part: "In war serve your country, in peace your convictions; discern, investigate, meditate and think, study, at all times be honest and generous. Let your firmest purpose be that of helping to see that each new generation shall be of a youth more efficient and capable, and in this let your own children be included."

# EISENHOWER CITES U. S. MEXICAN FRIENDSHIP

— President Eisenhower Tuesday night called attention of the growing bonds of friendship between the United States and Mexico.

In a message read on the radio

program "America's Town Meeting of the Air," President Eisenhower commended the opening of a sixweek discussion program on Mexican progress. Tuesday night's broadcast originated in Mexico City.

The President said in his message released here that friendship between the United States and Mexico "Is evident in the orderly way by which our two sovereign governments solve their mutual problems. It is apparent in the tremendous volume of commerce exchanged, and in the private investments which citizens of each country make in the other. It is manifested

culturally by the great numbers of our young people enrolled in such centers of learning as the Mexican-American Cultural Institute and by the Many Mexican students studying at universities in the United States."

He added that "More of us in the United States should learn about Mexico's great economic and cultural achievements over the past few years. And just as we can profit from studying Mexico development, so Mexicans can learn more about us and avail themselves of those material and spiritual values of ours which they may find useful for their own development."



The Supreme Court ruling holding that Jackson County, Texas violated the Constitution by keeping American citizens off of juries has given us an opening wedge in our fight for equal representation in matters that are important to all American citizens. Texas Attorney General John Ben Shepperd is correct in saying that this decision is applicable only to Jackson County, but has he overlooked the fact that it sets a pattern for our fight on equal rights for all citizens?

The Honorable Attorney General is campaigning for re-election. Does he, in his infantile reasoning, believe that we will support him in the coming election when we know that his thinking is so provincial? The problems of today must be dealt with by a broadminded, broad-thinking man.



Always be honorable and highminded, learn how to be self-reliant upon your own qualifications and resources.

In war serve your country, in peace your convictions; discern, investigate, meditate and think, study, at all times be honest and generous.

Let your finest purpose be that of helping to see that each new generation shall be of a youth more efficient and capable and in this let your own children be included.
