



"Ben Visualized the Possibilities of Better Opportunities"

Governors and Special Organizers find themselves in. I only hope that if we all push the Passive Membership Drive and make it a successful project, we might be able to give each of the above mentioned officers deserving financial assistance to further the expansion of the League. I believe the Regional Governors are primarily responsible to see that cities are approached by him or his District Governor in order to establish more councils. Lets all work hand in hand that our League might become stronger and recognized in every city and every state in the Nation.

I would like to remind all councils and officers that we have a deadline for submission of resolutions and constitutional amendments to the National Convention, and this deadline is 45 days prior to the Convention. May I suggest that much thought and effort be given to all resolutions and constitutional amendments in order to avoid last minute written resolutions which many times are mal-worded and misleading.

Lets remember 45 days before the National Convention or May 1st as deadline.

If we are to submit resolutions or amendments, let them be intended to serve the best interest of our beloved LULAC as a whole rather than individuals.

In reading our constitution we find many inadequacies which tend to slow our progress. Certain procedures should be changed to apply to the present era. Study your constitution and help us correct the inadequacies.

Once again we will have the honor at the National Convention of selecting the outstanding LULACs of the year. This is an honor bestowed upon two of the hardest working LULACKERS. If you find a truly good LULAC worker in your council or city, please submit a full report to the National Office. The next four months will provide all LULACKERS many opportunities to make a strong bid for the great honor.

To all of my Regional Governors, I would like to suggest that you instruct your District Governors to start arousing interest in every council in regards to the National Convention. We would like to have representation from every council in the League. Start making plans to charter busses, trains. or planes to take your district or state to the Convention in June. This is an opportunity seldom seen in LULAC. Those districts designated as such by the Regional Govorners should be sure that a District Govenor is elected. Remember that District Governors should have a well-defined district which should include at least one active council. You have four months in which to district your region and work up councils.

The month of March will mark the end of the third quarter, and some of our councils are still delinquent in dues for the first and second quarters. Payment of national dues is a prerequisite to qualifying delegates to the National Convention. Start making arrangements for those payments by quarters now and save your council the hardship of making one large lump sum in June.

Our constitution provides for payments to be made on or before the first day of the first month of each quarter, and all counnails waiting until convention time to make payments run the risk of having themselves ruled ineligible to participate in the convention, PREVIOUS PRACTICE NOTWITHSTANDING.

May I extend to all councils who have loyally followed National Office recommendations of the obesrvance of LULAC WEEK, my personal appreciation. Lets also cooperate with your National Director of Publicity so that the LULAC NEWS might be issued every month. There is plenty of work to be done for LULAC and you must help do it. God Bless You.

The League of United Latin-American Cítizens came into being on Feb. 17, 1929, at Corpus Christi, Texas. Twentyeight years and six days later, Feb. 23, 1957, San Antonio LU-LACc met at Youngblood's Restaurant to honor the founders of the organization that was born to combat plagues of prejudicial attitude that for several generations was directed at a large segment of American citizens commonly referred to as Latin-Americans for purposes of differentiation of origin or extraction.

The San Antonio fete honoring the LULAC founders was in observance of National LULAC Week and our three local organizations did the mselves proud in the event. A large representation from Ladies

Councils Nos. 187 and 282 was present as the San Antonio Men's Council No. 2 was happy to greet LULACs old and new.

Port Arthur Ladies In the News...



On February 14th, Council No. 298 (Montoya) had installation of officers and banquet.


Ladies LULAC Council No. 9 had a civic program and party dance on February 13th. Refreshments were served.

Minutes of The Texas Regional Convention

The League of United Latin and Arnold Quintero, Houston. American Citizens (LULAC) opened their 28th Anniversary Texas Regional Convention at 10:30 A.M., Saturday, February 16, 1957, with the Hon. Peter Tijering, Regional Governor, presiding, in the East Ballroom of the Lubbock Hotel in Lubbock, Texas. The official prayer was led by the Rev. Patrick, O'Brien, S.A.C. Chaplain, fol lowed by the Honorable Manuel Torres' leading the Pledge of Allegience to the Flag and by the assembly's singing in unison "The Eyes of Texas," accompanied by Miss Margot Rodriguez at the piano and led by Alfred Hernandez. The welcoming address by S. S. Forrest, Jr., Mayor of the City of Lubbock, was followed by a response by the Honorable Manuel Lopez of San Antonio.

The Honorable Alfred Hernandez, National Secretary introduced the National officers and quests.

Luciano Santoscoy, First National Vice President, was introduced and talked to the assembly in view of the fact that LULAC's good works and contributions to those in need are going unnoticed by the general public and stressed the fact our Public Relations Committee must sell to the public the works of LULAC.

The Honorable Pete Tijerina called the roll of District Governors and Delegates and appointed the following committees and committee chairmen:

Temporary Legal Advisor,

Paul Andow, El Paso.

Resolutions Committee, Chairman Joe Moreno, Austin; Manuel Gonzales, Waco; Lupe Esquivel, Bryan; E. B. Leon, El Paso; A. G. Ramirez, Lubbock,

Credentials Committee, Chairman Moses Hernandez, New Braunfels; Roy Velasquez, Austin; Edmundo Mediano, El Paso; Luciano Santoscoy, Exofficio and acting advisor.

Rules Committee, Chairman Manuel Lopez, San Antonio; Julian Hernandez, De Harris; Lionel Galindo, Lubbobck, and Janie Calderon, Edna.

A report was given by the Honorable Felix Tijering relating his recent work for LULAC and calling attention to the recent growth of LULAC; the problem of the lack of education of the Latin American People, both and through the barrier of language which is so important scholastically.

The Honorable William J. Gillespie, County Attorney of Lubbock County, Texas, addressed the assembly expressing the need of God and truth, and assured LULAC members that Lubbock was incapable of segregating Latin American children in public schools...

The Regional Governor concluded the morning session and announced the recess for lunch.

The afternoon session was called to order at 2:30 p.m. Saturday, February 16, 1957, by the Honorable Pete Tijerina who announced the first speaker of the afternoon, the Honorable George E. Gilkerson, District Attorney of the 72nd Judicial District of Texas. Mr. Gilkerson began by welcoming the LULAC delegates and then began his talk with the seven elements affecting the need in the future for a greater enforcement of the laws. The speech centralized around a demonstration relating that in order to get "Some-

where," one must have a gleam in his eye, must wear a cloak of decency and must posses a badge of courage; and if LU-LAC possesses these qualifications, it will recognize opportunity and make the most of it. Mr. Gilkerson's speech was answered by Alfred Hernandez.

Mr. Manuel Lopez reported on the findings of the Rules Committee of this convention. There being only one request, Mr. Lopez recommended that the tabling of motions and resolutions be waived, and that each motion or resolutution be either rejected or accepted, and made a motion therefor. The motion was seconded by Waco delegate, Manuel Gonzales. Felix Salazar of Houston, raised a question as to the actual meaning of the motion, which was clarified by Mr. Lopez. Isidoro Flores of San Antonio shortly affirmed the motion. A verbal vote was held, and the motion carried.

The Regional Governor opened the reports of the various districts by recognizing Joe Moreno, District Governor off Houston, District 7, who in turn introduced Mr. Obledo of Som Antonio and ex-president of the University of Texas Council. who introduced the new president and the members present. At this point the Honorable Pete Tijerina recommended to the Resolutions Committee that they find a ways and means of waiving the dues of students in universities and colleges.

Harlingen, District No. 13, reported the installation of a new council at Weslaco.

El Paso Districts Nos, 8, 132, 9, 267, 265, reported new councils, No.s 298 and 167.

Reports from Judge Allred in

the Driscoll case were distributed throughout the assembly to, if possible, be duplicated and mailed to every member of LULAC. A recammendation was made that a committee be formed to contact the Commissioner of Education in Autsin concerning this matter.

The Texas City problem was brought up for discussion, but the convention members were informed that it had been disposed of satisfactorily to LU-

Lubbock, District No. 1, reportedly had organized three new councils, and Mr. A. G. Ramirez was recognized at this

The Regional Governor announced to the assembly that all correspondence and memorandum were available for inspection by members who might be interested.

The Resolution Committee was asked to retire and to be ready to report their findings and conclusions when the convention recovenes on Sunday, February 17, 1957.

Discussion was held regarding whether Dr. Edgar, Commissioner of Education in Austin, had ever been contacted. After discussion by Mr. Hernandez and Mr. Tijerina, it was determined that Dr. Edgar had not been contacted but should be.

Fernando Cortez, National President of the Junior LULAC's was recognized and addressed the Senior LULACs asking the to help to sponsor a Junior LU-LAC to correspond with their individual District or town. Mr. Cortez related that this organization helped stop frequent

trouble-making. The activities of the Junior LULAC were related, and Mr. Cortez presented the Charter to the President of the Junior LULAC of Lubbock.

The meeting was then adjourned until 7:00 p.m., February 16, 1957, for preparation for the Semi-Formal banquet and ball which was held in the East Ballroom of the Lubbock Hotel.

The Rev. Patrick O'Brien, S.A.C. Chaplain, opened with the invocation. The Honorable Pete Tijerina presided and introduced the National Officers and distinguished guests, and introduced the principal speaker, the Honorable Dr. A. Duran, President of the Lubbock Council, who welcomed the delegates throughout the State to Lubbock. He noted the works of LULAC in forwarding American citizenship and education, pointing to the growing numbers of Latin-American youths in Texas colleges and universities.

Work being done by LULAC was emphasized further by the keynote address to the banquet made by Speaker of the House of Representatives, Austin, Texas, the Honorable Waggoner Carr, who singled out for special praise the work being done by LULAC in the education in the English language of Latin-American children near school age to make their school work easier. "LULACs are setting a good example for Texas," the House Speaker said, "they are doing things for themselves, standing on their own feet and not asking the government to do their work for them." He called on the organization to contribute further to the state's welfare by considering the individual problems of water, the school population, the prison and reform school populations. Mr. Carr also had kind words to say for Mr. Oscar Laurel, who accompanied him to Lubbock for the banquet and who had introduced him.

The evening concluded with

dancing and refreshments.

The final session of the League of United Latin American citizens was called to order by the Honorable Pete Tijerina at 9:45 a.m., Sunday February 17, 1957, in the District Courtroom of the Old Courthouse at Lubbock, Texas. The meeting was opened with the official prayer by Mario Obledo, followed by the Pledge of Allegience to the Flag led by Miss Edith Estrello, National Committee on Citizenship.

Scheduled speaker at this time, the Honorable Dudley Brummett, County Judge of Lubbock County, Texas, was unable to attend the meeting.

The Rules Committee, Manuel Lopez as chairman, requested three recommendations: that a delegate be present in order to vote; to limit speeches in favor of candidates during an election to only two speeches per candidate, each speech not to exceed 3 minutes; that no more than two speeches for and two speeches against, 3 minutes each, be allowed on any resolution. Leo Cardenas of the University of Texas, moved that the report of the Rules Committee be accepted, seconded by Mr. Estrello of the Edna Council. There was no discussion, and the motion was carried by verbal vote. This was followed by the roll call of the delegates, each answering as to how many delegates were present.

The Honorable Pete Tijerina thanked the Lubbock Council for the splendid convention arrangements.

The Chairman read to the assembly a telegram congratulating the members of the convention from Montoya Council president; another reflecting the same from Alfredo Garza of Laredo.

The Regional Governor turned over his report to the National President, Felix Tijerina.

Mr. Santoscoy related to the assembly that he had received

a telephone call from Frank Pinedo, Past National President of Austin, expressing regrets for his absence.

The Honorable Pete Tijerina asked that Oscar Laurel, State Representative in Austin, come to the rostrum to preside over the election of a new Regional Governor, with Richard Morales and Fidel Elizondo, both guests at the convention, to assist him. Mr. Laurel began with a small "booster" speech and offered his services to any of the members at any time.

Before the election began, Alvin No. 262 delegate advised assembly that he had seen J. C. Martinez, who was unable to attend the convention, and that Mr. Martinez had given him a tape recording to bring to the convention; however, no tape recorder was available to relate Mr. Martinez' message. Alvin delegate also relayed Mr. Martinez' warm regards to the convention delegates and members.

Mr. Laurel called for nominations from the floor. Manuel Lopez nominated the Honorable Pete Tijerina for another term of office. Mario Obledo spoke in behalf of Mr. Tijerina touching on the Batesville problem and ended his speech with a short prayer. Also, Alfred Hernandez of Houston and Tony Campos of Baytown made speeches in favor of the candidate. The motion was made by Manuel Lopez that the nominations cease. This motion was seconded by Moses Hernandez, and carried. Paul Andow moved that Pete Tijerina be elected by acclamation. The motion was seconded by Arnold Quintero, and Pete Tijerina was elected to serve another term as Regional Governor.

The Regional Governor introduced the National President, Felix Tijerina, who, in turn congratulated the Regional Governor on the new election result and commented on his past and expected future works for LULAC. The President also commented on Mr. Obledo's speech; asked for backing and

support of all members in order to make a stronger president. Mr. Tijerina also mentioned the fact that members should route their problems through the proper channels when seeking help; council president, District Governor, Regional Governor, and up to the National President. The last point stressed was that the members should assist every officer whom they elect.

Alfred Hernandez concluded his activities with a speech urging members to "love the organization" and to think of LULAC as whole, and not as individual members.

In closing Lionel Galindo of Lubbock led in LULAC prayer.

The motion was made by Moses Hernandez that the meeting adjourn and was seconded by Mr. Salazar. The convention then adjourned.

Rordiguez, Isauro Gutierrez, Antonio Vela, Ramiro Garcia, Reynaldo Homer Rodriguez, Gabriel Ernest Jr., Ramiro Jose Ramirez, Alfredo Chavarria. All were acompanied by \$15.00 fees, except M. S. Rodriguez, Reynaldo Rodriguez, Ernest, and Ramirez, who enclosed \$7.50 fees.

Claude B. Peña was voted in as a reinstated member. Reynaldo Montes Jr., and Leopoldo Rordiguez Jr., were voted new members.

Vice-President Ligarde called for committee reports. The Ways and Means Committee report was made by Arnulfo Zamora, chairman. He asked that the 11-man committee meet at 6:30 p.m. Thursday, March 28. He suggested that nothing be done to the present building until the council hears from the building committee.

The House and Grievance committee report was made by Arnulfo Zamora Sr. He reported a talk with Mrs. Muller, the owner of the present building. Mrs. Muller agreed on several repairs of the building, and was surprised when informed that the Council was planning its own building. Asked about the Council's option to buy the house, Mrs. Muller said it was agreable if they could come to terms, and that she was willing to let the Council have the building with no down payment. She didn't say how much she wanted.

Felix Garcia made the report for the Budget committee. He said that it took \$3,600 to operate last year. Estimated that it would take \$5,000 for this year. He asked, however, that he needed an estimate on membership for the year before embarking fully on the budget plans. He asked the team captains for an estimate. Judge Palacios said that would not be available until about a month.

Manuel Mauzimu made the Civic and Social committee report. He said that the Lulac Council had joined with the Kiwanis in the Heart Fund Drive. He offered Harry Galves to cooperate with the Cancer

Fund Drive. Raul Laurel Jr., said a program was due in about two days. Maizumi also reported, as suggested by Alfredo Garza, that Lulac's cooperation in the Crippled Children Clinic was very good.

Francisco Flores reported for the Youth committee. He said \$100 was needed from the Council right away to help send two boys to the National Scout Jamboree. He said an unidentified person had put in \$50 so all the committee needed to provide would be \$100. He asked the Council to provide the money with the understanding that later after Lent season the committee would replace it to the Council treasury. A motion, made by Flores and seconded by Elizondo, passed to that ef-

President Richard Morales told the membership that Felix Tijerina was planning to run again for National President and Morales wanted to know if the Council would support him. Alfredo Garza urged his support, calling his program progressive. Vice-President Ligarde asked for a motion. Morales made it, seconded by Davila, it passed. A second motion by Morales and seconded by Zamora made it unanimous. Morales then moved to have the Council campaign for the 1958 convention site, Zamora seconded and it passed.

Alfredo Garza and Rodolfo Centeno were named co-chairmen of a convention committee.

Garza was then called upon to present the program for the night, which was a cancer talk by Harry Galves, vice-president of the Cancer Society.

Before the program started Morales asked for a motion to Elizondo made it and everybody seconded, it passed, Acting Sgt.-at-Arms Junios Vasquez, after the program, announced that 43 members were present. The raffle was won by Arnulfo Zamora.


