Message from the National President

As the time approaches for the end of my tenure of office and as I look in retrospect at what has transpired in the past year, I feel happy to note that we have made some gains.

In the field of expansion we have moved forward; our membership has increased and we have brought the state of Colorado back into the LULAC fold. The District of Columbia will possibly be organized by the time we meet in Houston for our National Convention.

On the sad side of the ledger we have the LULAC NEWS, which has been, is and I am afraid, will continue to be the sore spot in every LULAC administration. While I will not attempt to make excuses for the delayed publication and the apparent hit and miss mail service of the LULAC NEWS, our League must bear some of the blame for this poor showing. First of all, the response for advertising has been so poor that the revenue taken in from the sale of ads for our News couldn't even pay for the postage expense for the mailing of one months publication. I feel very proud to have shared in this movement with men like ED QUEVEDO and BERT CORONA from MAPA; AGUSTIN FLORES from the American G.I. Forum, Dr. MIGUEL MONTES from LACA; AL PINION from CSO; RUDOLPH "CORKY" GONZALES from Denver; ALBERT PENA from PASO, MACLOVIO BARREZA from Tucson, ERNEST SANCHEZ from Albuquerque, and many other brave and dedicated Mexican-Americans who took a firm stand in a fight for justice-and equality.

Much of success of LULAC during the year in the field of employment we owe to the help of Girard Clark, Director of Contract Compliance for the Department of Defense; Bob Ornelas and George Royball. To Charlie Erickson from Los Angeles we owe a debt for his five journalist efforts in publicizing the stand of the Mexican-American.




SER Appropriates \$382,450.

The project is for two years and job placement centers will be in El Paso, Corpus Christi, San Antonio, and Houston, Texas. There will be others in the four Southwest states.



Mr. Chairman:

You and your Committee have three avenues open as well as opportunities to serve the youth in your community. You may grant Scholarships; give merited recognition by means of awards; or furnish needed financial assistance through student loans. You have an excellent opportunity to give the young people of your community the moral support needed and at the same time instill confidence, trust, and friendly interest in the ambitious student while he is working towards his educational goal.

SCHOLARSHIPS

These are grants made to students from the Scholarship Fund. They are outright gifts which need not be repaid to the Council. The local Council is at liberty to establish the qualification and requirements to be met by the recipient of all scholarships. Some of the requirements included by some Councils are:

- A. Need; high scholarship attainment; good character; leadership qualities; ability to get along with others; willingness to work for part of his college education; residence within the territorial limits of the local council; interest in extra-curricular activities; and a desire to contribute through education to the benefit of society.
- B. Some Councils require that the recipient practice in the State where the local Councils is located, if he or she is a professional. Some also limit their Scholarships to a certain field. Most Councils request a letter from the applicants' Church, Lawyer, Doctor, and Principal of the School he is graduating from.

AWARDS

These are usually a certificate, medal, or trophy given to a student in recognition of a past achievement and as an incentive to increased effort in his studies and extracurricular activities.

The main reason for presenting awards is to inspire students to increased efforts. Awards are made for different types of accomplishments, such as, high scholastic attainments, good citizenship, service to the School or Community, etc. The selection of the prize winning student may be made by fellow students, teachers, or a LULAC Committee. Awards are presented at School assemblies, official graduating exercises, or at a local Council Meeting, with the prize winning student and his parents as guests of the local Council.

STUDENTS LOANS

These are sums borrowed from the local Council Student Loan Fund to make up all or part of the difference between the student's actual expenses and the amount he himself is able to provide towards his College Education. This indebtedness - with or without a small rate interest - to be repaid by the Student to the Council after graduation.

There may be many reasons why students loans are made. However, we are concerned here only with two reasons: 1) A Student appreciates a loan more than an outright gift.

2) He will experience a certain sense of responsibility in having to pay back an obligation of honor which he has contracted. Besides, it will cause him to exert more effort in his studies since it is costing him something of material value.

It behooves the local Council to establish a revolving fund, because it can lend assitance to a larger number of young people.

Your Committee will be charged with the responsibility of investigating ways and means of initiating this activity and of setting up the fund on a sound business basis.

- A. In order to help you get started, here is a suggested plan:
 - 1. Determine the number of students who need financial assistance and also the amount of money that the local Council can afford to loan out to the students who wish to continue their college education.
 - 2. Obtain all pertinent information regarding State Regulation covering small loans.
 - 3. Consider the idea of incorporating the fund on a non-profit bases under existing local laws.
 - 4. After the preliminary study of how the fund should function you will be able to draw up regulations to be presented to the Executive Board.

FUND RAISING


One of the many methods employed to raise the necessary money for the Scholarships or the rotating students loan fund is to invite the ex-alumni of the particular school that is to receive the Scholarships as well as the Juniors and Seniors to sell tickets for the "before graduation dance," to which all the student body is invited.

DUTIES AND FUNCTIONS OF EDUCATION COMMITTEE

The responsibilities resting upon the Committee on Education are undoubtedly serious and grave, yet the working policies to be observed by that Committee shall have to arrived at by careful planning and consideration of the committee acting in conjunction with the Council. Matters which fall under this joint concern shall be those having any bearing on our children and their education, namely, welfare of the children, devising or fostering of improvements and facilities, equipment, safety, and buildings of our public schools, feeding of indigent children, and providing a Scholarship Fund for worthy students.

LET'S LEAVE POLITICS TO POLITICIANS

In the April 1966 issue of LULAC NEWS our National LULAC President suggests that we amend our League's Constitution to allow us to envolve ourselves in politics. He enpines that we must participate in politics so that we can impress the politicians or government officials, whom he states will only "listen to those who carry weight and have a voice in politics and strength at the polls." He further states that, "he has confidence in our future leaders of the League and in their ability to utilize the office, and prestige of our League to the furtherance of our aims and principles and the enhancement of the people of our ethnic group."

I have no quarrel with politicians, either good or bad. They have been amongst us since time inmemorial and I am certain that they will be around in future generations, still trying to subordinate good citizens and fine organizations to a robot-like status. It is true, however, that we have some fine politicians, but these are too few. I offer my heart-felt appreciation to those politicians who have achieved the statesman category through their untiring, genuine upright efforts in behalf of our communities and their disadvantaged citizens. As a rule, we are plagued by the irresponsible, corrupt type of politician whom, to say the least, do not merit our sympathy. Let us leave them to their conscience and their day of Judgement.

The idea of converting LULAC into a political organization is absurd. First, because LULAC cannot depart from it's service or civic role, nor can it be a service and political organization at the same time. Our LULAC Constitution has committed our League to the service of our Spanish-Speaking community. This is very clear in it's Preamble which resolves "to constitute this League into a service Organization . . . for the attainment of the highest ideals of our American society. LULAC has distinguished itself in it's unique service to our Spanish-Speaking communities. Secondly, the idea is absurd when we consider that if we allow LULAC to become political, we, in effect, are allowing our political-minded brethen, in our midst, to subordinate our League to a National political party. This reasoning is supported by Webster's definition of a politician whom he describes as "one addicted to, or actively engaged in politics as managed by (political) parties. Thirdly, Webster's further definition describes a politician as: often, one primarily seeking profit from them (political parties) as a source of private gain." Elaboration of the foregoing is superfluous.

LULAC has a noble purpose to fulfill as a service-civic organization. It has the highest of traditions to uphold and defend. We cannot reason with opportunists, but we can, and we do invite all genuine LULAC to close ranks and continue their service-civic and patriotic pursuits, within the League, in a non-sectarian, non-partisan Manner, teaching and defending the democratic principles of INDIVIDUAL political and religious freedom. We encourage and offer our best wishes to our political-oriented Brother and Sister Lulacs in their quest of political prominence or eminence, but OUTSIDE our beloved LULAC organization.

Responsibilities and Duties of a District Director



RESPONSIBILITIES

It shall be the responsibility of the District Director to be constantly aware of the condition of the Councils in his District, to assist them when possible, to hold District Council meetings when necessary to coordinate the activities of the Councils without infringing upon the automony of the individual Councils and their right to carry forward the work of LULAC in accordance with the needs of the Council's respective community.

The District Director shall have the prerogative of examining the books of any Council in order to determine its financial status.

The District shall meet in a District Convention during the month of April of each year at a place designated by the previous District Convention. The District Secretary-Treasurer shall notify all Council Presidents, the State Director and District Officers of the place, date and time of the District Convention not less than 60 days prior to the opening date of the Convention.

DUTIES OF THE DISTRICT DIRECTOR

It shall be the duty of the District Director to: assist in the organization of new Councils, supervise and counsel local councils in his District.

Present Charters to, initiate members and install officers of local councils at such time and place as he and the councils concerned designate. Such duties may be delegated to any National or State Officer or Council President.

He may declare a local council within his District defunct if it does not maintain the requirements of an active council as defined by the Constitution, By-Laws and Protocol and shall so notify the State Director and the Supreme Council.

To make a quarterly Report of the condition of his District to the State Director.

To make a periodical tour of his District and to be available within reason to those councils requesting his aid and advise.

To call a meeting of the council presidents of the councils in his District at any time for the purpose of conducting business between District Conventions.

To have a voice and vote at the State and National Conventions and a voice at a meeting of the Supreme Council.

To issue a call for a District Convention to be held during the month of April and to preside at such Convention.

In the absence of the District Director at a State Council Meeting the Deputy District Director shall, acting as an alternate, assume the duties of the District Director and he shall be entitled to a vote on the State Council in lieu of the District Director.

In the event of resignation, death or removal of the District Director the Deputy District Director shall assume the office of District Director for the remainder of the term of office.

A vacancy occurring in the District Council, other than the Council Presidents shall be filled by the District Director with the approval of the District Council.


